 of Ratifying the aforesaid Frame of Government if they see fitt
- 2^d For the town to bring in their Votes for a Delegate as the Law Directs
 or act thereon as the Town shall think fitt when met
- 3^d For the town to Choose a moderator for the Remaining Part of the
 Warrant
- 4th To See if the Town will make any Addition^{to} or Alteration in
 M^r Abisha Coltons Call or Pass any vote or Votes as the Town shall
 think fitt when met Relative to said Call
- 5th For the Town to hear a Letter from Asahel Moore Sent to the
 Select Men and act thereon as the Town shall think fitt when met
- 6th For the town to Consider of and allow all towns debts to whom the
 Town is Justly Indebted
- 7th To See if the Town will grant to the widow Silvester Satter
 any pier wood and act thereon as the town think fitt when met
- 8th To See if the Town will make Sale of any Part of the Common Land
 the Back Side of the meeting house or Pass any Vote or Votes as the
 Town shall think fitt when met
- 9th To See if the Town will Sell to Elijah Johnson M^r M^r M^r Bond
 relating to the mill Satter owned by Andrew Newton now lying in
 the hands of the Select men or act thereon as the Town shall think
 fitt when met
